Provisions for the publication of the thesis

As set out in § 17 of the doctoral regulations, you must publish the thesis in the version approved by the referees within two years following the oral examination.

If the thesis is not published within this period, you forfeit all rights attained through the examination. Upon prior application, the head of your department can extend the time limit in justified cases.

If one of the referees does not approve the version to be published because it does not match the version assessed, or deviates unacceptably, the Doctoral Committee shall make the final decision.

The required presentation copies must be sent **free of charge** to the following <u>postal ad-</u> <u>dress of the library</u>:

Presentation copies must be delivered to the library of the University of Konstanz (hereafter: library) free of charge upon publication.

The following four options for publication are permissible:

(compare § 17 Sec. 2 doctoral regulations)

- [1.] If a commercial publisher assumes the task of distribution to book dealers and a minimum print run of 150 copies is proved, **six copies of the book** must be delivered to the library. Delivery is deemed to have been made if the publisher makes a binding statement to the *Zentrales Prüfungsamt* (Central Examination Office) to the effect that both the printing of the thesis and the financing thereof are assured, and that the required copies will be sent to the thesis section of the library immediately and without charge; and provided that all necessary approvals of the release for printing from the reviewer and the referees have been filed with the *Zentrales Prüfungsamt*. The publication duty is fulfilled if the thesis is published within two years after submission. In justified cases and upon prior application, the head of department can extend this time limit with the consent of the supervisor. Otherwise, you forfeit all rights attained through the examination.
- [2.] In case of reproduction by means of the customary methods (letter press, image printing or microfiche), you must deliver 40 presentation copies to the library.
 If the thesis was in the **field of chemistry**, publication in the form of microfiche is **not permitted**.
- [3.] If the thesis is published in a scientific journal, you must deliver six reprints from this journal as well as six copies of the complete thesis to the library. This form of publication, however, is not possible in the field of law.
- [4.] If the thesis is published in electronic form on the internet or other comparable network that is publicly available, it must be made available to the library in electronic form as well. Please observe the formatting requirements set out by the library. The library will promptly publish the thesis in the network. On request to the library and with the supervisor's consent, the thesis may be published at a later time; this application must be submitted before the dissertation is published. You have to deliver another four copies of the entire thesis printed on paper using one of the customary methods named above to the library as well. The publication duty is fulfilled if the thesis is published within two years after submission. In justified cases and upon prior application, the head of department can extend this time limit with the consent of the supervisor. Otherwise, you forfeit all rights attained through the examination.

In the **Departments of Mathematics and Statistics** as well as **Computer and Information Science**, you have to consider the department-specific standards for the publication of the thesis, especially if published in electronic form.

<u>Please note:</u> Always contact the library directly for the publication of your thesis in electronic form (contact details, please see page 1).

In case of publication in the form of microfiche, each copy must be stored in a microfiche cover.

Before choosing one of the four publication options of your thesis, please contact the referees beforehand to make sure they agree with that option. Only after you have obtained their signatures on the attached form should you contact a publisher, copy shop etc. to take further steps.

When do I get the certificate of my doctor's degree?

As soon as the *Zentrales Prüfungsamt* (Central Examination Office) has received the form signed by all referees, and the confirmation of the library of receiving the presentation copies of your thesis, you will receive your certificate.
