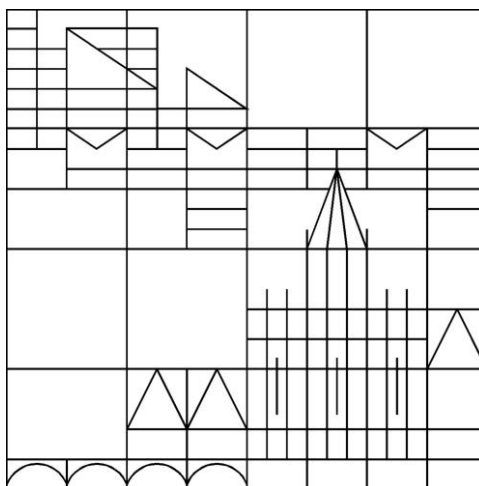

I. Qualification goals of the Master's degree programme in Linguistics

In the Master's degree programme in Linguistics, students acquire the knowledge, skills and methods required to be able to carry out linguistic analyses, present and notate them according to commonly accepted conventions. They become familiar with linguistic structures, their historical development and variation; either cross-linguistically (focus on General Linguistics), or in specific languages (within English Studies, German Studies, Romance Studies, or Slavic Studies). In the double-degree programme with the Università di Verona, students are additionally familiarized with topics in applied linguistics. Students become aware of the current theories and methods of linguistics, can describe linguistic structures, and can independently formulate and solve clearly delimited theoretical problems. They acquire the ability to use contemporary technologies for linguistic analysis.

Subject-specific objectives of the linguistics Master's degree programmes:

The Master's degree programmes deepen the knowledge and skills acquired in the Bachelor's degree programme in selected areas. The content conveyed at this level is more demanding. At the same time, students can develop their own profile with a view to the Master's thesis and career perspectives:

- Students become familiar with current theories of linguistics, with a focus on General, English, German, Romance, Slavic, or, in the double-degree programme with the Università di Verona, applied linguistics.
- Students acquaint themselves with the current methods of linguistics and are able to collect, analyse and interpret data in a scientifically sound manner.

General objectives of the Master's degree programme in Linguistics:

Through the medium of linguistics, students also acquire more general skills that qualify them for a profession:

- Students can think analytically and abstractly and analyse complex systems.
- Students can argue clearly and precisely in speech and writing.
- Students can follow presentations with complex content and can acquire and understand informal as well as technical material on their own.
- Students can deal critically and analytically with different types of texts and evaluate them with convincing arguments.
- Students can use libraries and the Internet sensibly and effectively, and can cope with complex amounts of information with an eye for the essential.
- Students can deliver their own clearly thought-out, well-structured and linguistically concise presentations, both oral and written, in a variety of formats.
- Students can motivate themselves to produce work independently and can use time effectively to do so.

II. Outline of the Master's Programme Linguistics

In the Master's Programme *Linguistics*, students choose one of the following areas: General Linguistics, English Linguistics, German Linguistics, Romance Linguistics or Slavic Linguistics. A total of 120 ECTS credits (cr) must be earned, of which 54 cr are in the general modules (modules 1, 2 and 7) and 66 cr in the areas of specialization (modules 3-6).

On the basis of the cooperation agreement with the Università di Verona, students can complete the Master's Programme Linguistics as a double-degree programme. In this case, either the first year is completed at the University of Konstanz and the second year at the Università di Verona ("home university" Konstanz), or the first year is completed at the Università di Verona and the second year at the University of Konstanz ("home university" Università di Verona). This Double-Degree Option with the Università di Verona (DD UniVer) forms its own area of specialization.

In the DD UniVer, students have a wide choice of courses to select from. However, course offers change depending on the home university. Students must earn a total of 120 cr, with a minimum of 40 cr in the first year.
